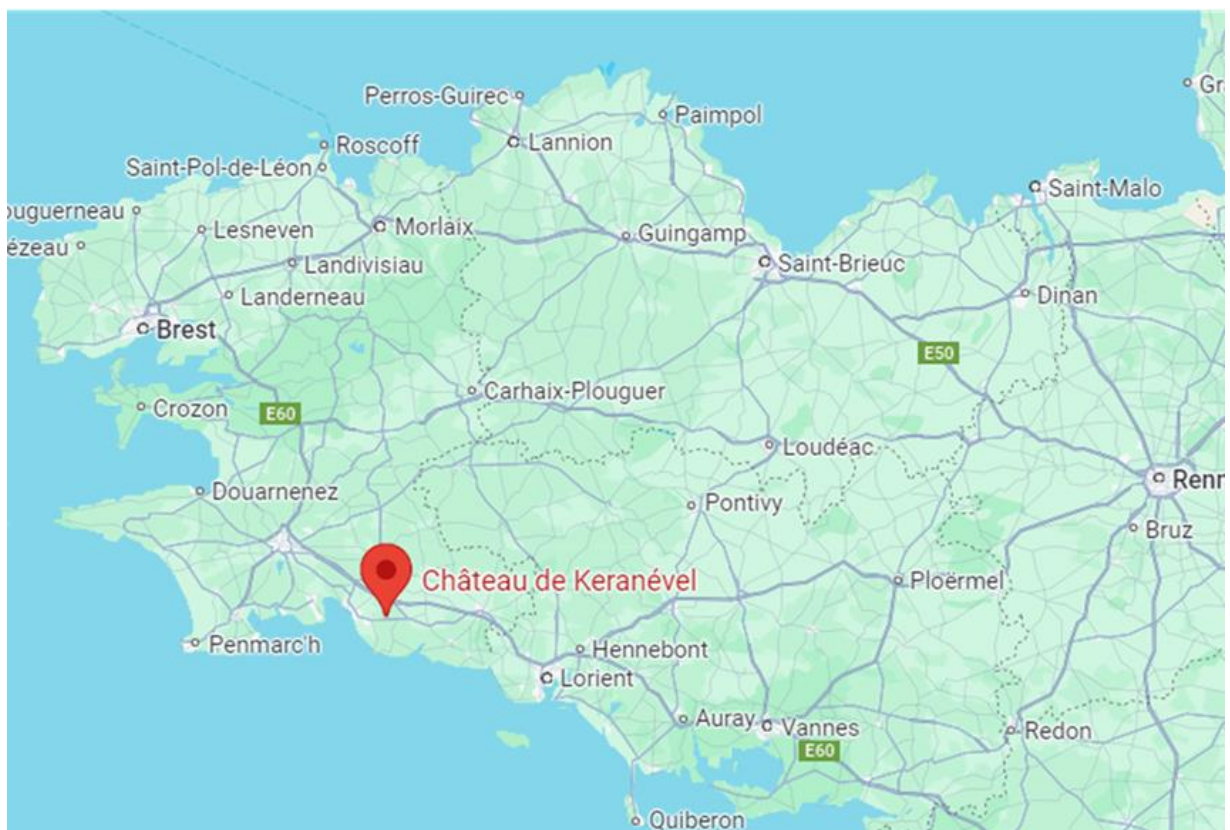

## **INTERNAL RULES**

### **19th SIMCA meeting organized by the Club Simca France**

**from May 29 to June 1, 2025 in Melgven (29)**

**Article 1:** The reception is open from Thursday to Sunday from 9:00 a.m. to 7:00 p.m. The meeting is reserved primarily for owners of SIMCA cars and derived brands. Different parking areas will be set up to classify cars by model or year. Collectible cars other than Simca will be parked in a specific area of the visitor parking lot. Any vehicle with a noise level higher than current standards will be refused.

**Article 2 :** The site is divided into several zones (exhibition, exchanges, shop, various activities), all of which must be respected. The site has a direction of traffic which must be respected. The maximum authorized speed is 10 km/h. Parking for exhibitors, as well as for car carriers, will be set up and marked inside the site. All trailers must be equipped with an anti-theft system, the organizers cannot be held responsible in the event of theft or damage.

**Article 3 :** Camping is authorized only for vehicles, hitches and vintage tents in the retro camping area. The space is not equipped with water or electricity

**Article 4 :** Fires and barbecues are strictly prohibited on the entire site.

**Article 5 :** The event site will be closed each day from 7:00 p.m. Patrols will be organized regularly at night whenever possible.

**Article 6 :** Participants are required to respect the basic rules of safety, decorum and cleanliness. Selective waste collection points will be set up. All dogs must be on a leash; their owners must ensure the disposal of dog waste. Dangerous dogs are not allowed.\*

*\*Order of April 27, 1999 taken for the application of article 211-1 of the rural code establishing the list of types of dogs likely to be dangerous and subject to the measures provided for in articles 211-1 to 211-5 of the same code.*

**Article 7 :** The organizers reserve the right to immediately exclude any person who does not comply with these requirements without any compensation. The same will apply to any car driver practicing dangerous driving or excessive speed.

**Article 8 :** A bracelet will be given to you on the day of your arrival; wearing it is compulsory for the entire duration of the event for all people with access to the site.

**Article 9 :** Children are under the full responsibility of their parents or accompanying adults. Club Simca France will in no way be held responsible in the event of an incident or accident.

**Article 10 :** Carss which obstruct access reserved for emergency and fire-fighting vehicles will be evacuated by the organization.

**Article 11 :** The tourist routes run on public land. Their aim is to help you discover the region's remarkable sites. All vehicles and equipment must be covered by an insurance policy that complies with current legislation. **Article 12 :** The organizers cannot be held liable in any way for the damage that drivers could cause to others nor for those they could suffer as long as the elements directly linked to the organization's liability are not explicitly called into question.

**Article 13 :** The parts exchange for professionals is subject to special regulations.

**Article 14 :** Any sale of car parts and other items outside the stock exchange area is strictly prohibited. Any advertising (posters, placarding, flyers, etc.) must be subject to prior agreement from Club Simca France.
